CITB Site Safety Plus Scheme rule changes

What construction training managers and self employed site managers need to know.

Introduction of written exam answers means the delegates understanding and application of English language is now essential.

Site Safety Plus (SSP) provides the construction industry with a suite of courses for health and safety awareness and career development to help maintain a safe workforce. Citto Rule changes for 2018

Changes to the Site Safety Plus courses and Health, Safety and Environment (HS&E) tests came into play January 2018. The rule changes are already impacting on SMSTS and SSSTS delegate pass rates across the UK. Especially for those sitting 'refresher courses' for a second or third time in their career – because the new exam format is taking delegates by surprise.

Pre-course Delegate Assessment

Delegates must have the...

physical ability

communication skills

✓ literacy

numeracy

and the required experience and skills

...to ensure they are competent to attend and complete the course.



Course Requirements

All SSP Courses must be taught in English.

All delegates must present photographic ID on the day of the course exam.

✓ Driving License

Passport

All sessions must be attended in sequence and without full attendance the certificate cannot be awarded. No delegate is allowed to attend more than two courses of split attendance. If this is not possible the delegate must enroll on a new course and retake the full course.

If the course is a 'Refresher' then their current credentials must be within the allowed period and not expired.

Exam Requirements

SMSTS course & SMSTS refresher course

- 20 multiple choice questions including 5 safety critical which must all be answered correctly to pass
- 5 written answer questions

SSSTS course & SSSTS refresher course

SSSTS Assessment Exercise: Delegates have to produce a risk assessment and method statement for a typical construction task. (Marks out of 100. Not applicable to refresher).

- 22 multiple choice questions including 4 safety critical questions which must all be answered correctly to pass
- ✓ 3 written answer questions

CITB Approved Training Organisation (ATO) status

RISK have been an accredited CITB training provider since 1997 and as a CITB Approved Training Organisation (ATO) are embracing the strategic changes being rolled out. RISK have refined its unique training materials and processes to optimise the delegates understanding of what's important and why.

RISK have created a process to deliver the best chance of passing first time.

CITB request the ATO conduct a pre-assessment on the delegate. The criteria for this is set out above, however, as many delegates are booked directly on to courses via a training manager, and the CITB course may only be a two day refresher, this is difficult to control or apply fairly and consistently pre-course. RISK have developed a process which incorporates an initial induction paper which acts to perform the 'pre-course' assessment and highlight the relevant details of the Guaranteed Pass Scheme. The specific criteria of the course and what's expected of the delegate in relation to learning the materials. together with T&C's of the RISK Guaranteed Pass Scheme – are all clearly set out within this short pre-course induction.

Innovative teaching style and supporting materials designed to give the best chance of passing.

A written exam format means the delegates understanding and application of English is essential.

The delegate is no longer assessed by multiple choice questions alone, there are now an additional number of short written statements to also complete. This is to demonstrate their understanding of the issues faced in the exam questions posed. These statements are then marked objectively on the quality of answer of the issues faced, the relevant health & safety law and how they ensure compliant and safe working practices. Where a delegate submits an answer which may deemed borderline by the course leader, they may be interviewed to explain their answer further. Therefore the application of both the delegates spoken and written English will be a major factor in their ability to successfully complete the course.

Guaranteed Pass Scheme on all CITB Courses

If the delegate meets the course criteria and completes the RISK homework set – RISK guarantee to continue to support the delegate until they have passed the course. The only costs they will incur are those of the actual governing body for resitting the exam.*

RISK homework is a combination of supporting course materials and mock exam papers created by RISK.

The homework is to ensure the information delivered during the day has been absorbed and the delegate has the practical experience of providing legible written answers to the questions posed. Retaking the relevant exam the same day is free, and requires no additional fee from RISK or CITB. The retake exam paper is different, but the delegate will have had their initial exam paper scores explained and been given some pointers on where and how to improve for the retake.

New global health and safety standard



ISO 45001, the long-awaited new international standard for occupational safety and health, is set to be published in March 2018

It will be the first global standard of its kind, says the International Organisation for Standardisation (ISO), giving organisations 'a universally accepted framework for improving employee health and safety, reducing workplace risks and creating healthier, safer working conditions'.

The standard follows the generic management system structure used for ISO 14001 and ISO 9001

It was based initially on OHSAS 18001, but also takes account of other influential documents, such as the International Labour Organisation's ILO-OSH Guidelines and various national occupational safety and health management system standards.

Steep increase in high fines for organisations and custodial sentences for individuals

The 2016/17 data on prosecutions released by the UK Health and Safety Executive (HSE) shows a large annual increase in fines. In 2015/16, the total fines for health and safety offences was £38.8 million. This rose to £69.9 million in 2016/17. The average fine per case in 2016/17 was approximately £126,000, which is more than double the average fine in 2015/16. Notably, the ten highest fines in 2017 ranged between £1.35m and £3m.
